- The Bazine charge and the Arnold-Ransom charge have become the Arnold-Ransom-Bazine charge.

Hutchinson District

- Arlington and Sylvia, each stand-alone charges, have joined as Sylvia-Arlington, a two point charge.

Wichita East District

- The Grandview-Burden charge has been dissolved to become two stand-alone charges: Burden and Winfield, Grandview.
- The Cassoday-Burns charge and the Leon charge have become the Leon-Burns-Cassoday charge.
- The Saint Mark United Methodist Church and the Epworth United Methodist Church merged to form the Saint Mark United Methodist Church (effective June 1, 2013).
- The Udall-Cedar Chapel charge has re-aligned to the Derby, Madison Avenue-Udall charge with Cedar Chapel moving to the Wichita West District (to form the Bethany-Cedar Chapel charge).
- The Derby, Madison Avenue charge and the Udall charge have become the Derby, Madison Avenue-Udall charge.

Wichita West District

- The Grace-Bethany Charge has been dissolved. Grace is now a stand-alone charge and Bethany joined with Cedar Chapel from the Wichita East District to form the Bethany-Cedar Chapel charge.
